# Modern Slavery and Human Trafficking Policy



## 1. Introduction

Progressive Legal Solutions is committed to preventing modern slavery and human trafficking in all aspects of our operations and supply chains. While we are not legally required to publish a statement under the Modern Slavery Act 2015, we voluntarily uphold ethical standards and seek to ensure that our business and supply chains remain free from any form of exploitation.

## 2. Organisational Structure and Supply Chains

Progressive Legal Solutions provides conveyancing services, including regulated local and council searches, environmental and planning reports, drainage and water reports, mining reports, title indemnity insurance, company search reports, energy performance certificates, and chancel liability assessments.

Our operations are based in the United Kingdom, with offices in Cardiff, Henley-on-Thames, and Newcastle Upon Tyne. Our supply chains primarily involve UK-based suppliers providing essential services and products.
